## **Introduction**

This policy regulates the transition of the National Accreditation Authority (hereinafter referred to as NAH) from MSZ ISO/IEC 27006:2013 to ISO/IEC 27006:2015.

### **1. International requirements**

Pursuant to IAF Resolution 2015-12 of the International Accreditation Forum (IAF), organisations accredited for information safety management system (ISMS) certification must comply with ISO/IEC 7006:2015 after the passage of 2 years calculated from the date of publication of the standard:

a) **As from 01 October 2017**, only those ISMS certification bodies can be deemed to be accredited in whose case an accreditation body will have confirmed by this deadline that their certification activities under ISO 27001:2013 (MSZ ISO/IEC 27001:2014) fulfil accreditation requirements laid down in ISO/IEC 27006:2015.

b) Accreditation documents related to ISMS certification under ISO/IEC 27006:2011 (MS ISO/IEC 27006:2013) will lose effect as of 30 September 2017.

NAH will integrate into its own accreditation scheme; apply in its own procedures; and enforce against bodies accredited by it IAF rules.

ISMS certifiers can prove consistency of their certification activities with ISO/IEC 27006:2015 within the scope of scheduled annual surveillance audits, accreditation proceedings or unscheduled surveillance audits.

### **2. Rules pertaining to the deadlines of NAH procedures**

When evaluating certification activities in accordance with MSZ ISO/TS 22003:2014 technical, NAH will proceed as follows by the deadlines laid down in international requirements; Act CXXIV 2015 on National Accreditation; Government Decree 424/2015 (23 December); and Act CXL 2004 on the General Rules of Administrative Proceedings and Services:

2.1 As from 01 October 2016, NAH will verify ISMS certification bodies during accreditation and surveillance proceedings in accordance with ISO/IEC 27006:2015. **Assessment will take by way of documentation reviews; local visits and surveillance audits applied in combination.**

2.2 Organisations accredited for ISMS and not subject to a scheduled surveillance audit in the transition period must apply for an unscheduled surveillance audit whereby NAH will verify consistency with ISO/IEC 27006:2016. An unscheduled surveillance audit can be applied for until 01 August 2017.

2.3 ISMS accreditation requests submitted after 01 October 2016 will be audited by NAH for compliance with ISO/IEC 27006:2015.

2.4 NAH will withdraw accredited statuses certifying consistency with ISO/IEC 27006:2013 and granted with validity dates falling after 01 October 2017 as of 01 October 2017.

2.5 In the event of failure to meet the above deadlines, NAH will not be in a position to ensure that certification bodies fulfil ISO/IEC 27006:2015 accreditation requirements for ISMS certification by the deadlines set by IAF.

### **3. Tasks of management system certification bodies**

3.1 The head of the organisation certifying accredited management systems must make a declaration by 29 February 2016 as to whether it shifts to MS EN ISO/IEC 17021-1:2016 requirements.

3.2 In order to ensure smooth transition, it is advisable that management system certification bodies draw up a transition plan and send the same to NAH for consultation before applying for the next surveillance audit.

### **4. Closing provisions**

4.1 This policy is issued by the NAH General Director by way of General Director's Instruction no 21/2016.

4.2 This policy will enter into effect as of 22 August 2016 and, due to the transition deadline, expire as of 01 October 2017.
